Wes Bryan reported on the new Entrepreneurship Certificates to be offered for the first time this coming Fall semester. The program is designed for students seeking to explore and plan the startup of a business. One of our past board members Bern Baumgartner was key helping put this program in place.

Wes also announced all home football games will be played at GWC this coming season. The Student Government has funded the rental of bleachers and purchased a scoreboard for the athletic program.

MEASURE M UPDATE

Bruce Berman and Wes Bryan gave an update on all current Measure M projects.

WISH LIST CHANGES

Bruce Berman gave a report on the changes for the upcoming 2018 Wish List / Student Impact Project.

The budget for this project was increased from \$40,000 to \$50,000 and will be broken down in to two categories:

- One \$25,000 grant
- Remaining \$25,000 for traditional applications.

Bruce will be working with Wes and our Research Analysis team to come up with guidelines for the one-time grant and will be focused on student-impact.

EXTERNAL INVESTMENT COMMITTEE UPDATE

Steve Olmsted reported the external investment committee has been formed and will be meeting to review procedures for their role. Yvan Cao will be overseeing the transfer of funds within the next month from HighMark to Schwab.
